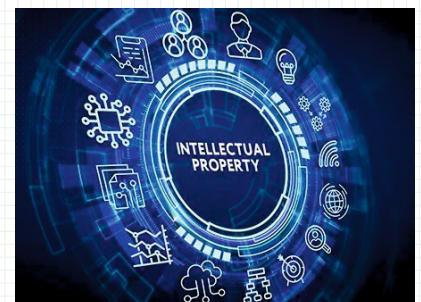

Guidelines for Abstract Submission

The participant interested should submit an abstract of their original research describing objectives, methodology and its implication in about 350 to 500 words by 2nd April, 2024. All abstract will be evaluated before final acceptance. Authors of accepted abstracts will be invited to submit and present full paper at the seminar.

Further, participants are requested to send their unpublished original research paper along with relevant references/footnotes/end notes between 2500 to 4000 words for any one of sub-themes latest by 4th April, 2024. The abstract and full paper should be submitted in MS word typed in Times New Roman with 12 font size with 1.5 line spacing with sufficient margin.
